Nikola Tesla: A Follower of Ancient Knowledge and a Visionary of the Future


These days, we often come across the headline: "A Discovery on the Giza Plateau Shakes Everything We Thought We Knew"...


A research team consisting of Filippo Biondi, Corrado Malanga, and Armando Mei conducted a study using Doppler tomography and **S**ynthetic **A**perture **R**adar (SAR) to investigate the internal structure of the Great Pyramid of Giza. Their research was initially published as a preprint on arXiv on August 1, 2022, with a peer-reviewed version later published in *Remote Sensing* on October 19, 2022. The results of this study were first presented to the public on March 16, 2025, at a conference in Castel San Pietro Terme, Bologna [1].

Their findings suggest the presence of new, previously undiscovered internal structures within the pyramid, offering fresh insights into its construction and purpose. The study proposes that these internal features may have functioned as components of a "great resonator," potentially indicating that the pyramid served purposes beyond being merely a tomb. It is important to note that while these findings are intriguing, they represent initial interpretations based on SAR data analysis. Further archaeological field research and peer-reviewed studies are required to confirm these conclusions and fully understand the implications of the proposed internal structures.

However, what has been discovered beneath the pyramids is even more fascinating. In addition to new artifacts revealed within the Great Pyramid through SAR tomography and the reconstruction of its complex 3D structure, the findings beneath it are simply astonishing:

- Five massive structures near the pyramid's base, connected by geometric passageways. Each has five horizontal levels and sloped roofs.
- Eight vertical cylindrical shafts, hollow and surrounded by spiral descents, extending 648 meters underground beneath the pyramids.
- These cylindrical structures are connected to two massive cubic formations, approximately 80 meters
 per side, forming part of a system extending two kilometers beneath the plateau—under all three
 pyramids.






The clearly defined geometry of this underground complex unequivocally suggests that it is a manmade structure, consciously designed and purposefully constructed for an unknown function.

For a long time, mainstream Egyptology has insisted that the pyramids were built as tombs. However, these discoveries—combined with the pyramid's precise geometry, which incorporates fundamental cosmic constants such as Pi, the golden ratio, and even the speed of light - challenge and potentially overturn that narrative.


Both the aboveground and underground complexes exhibit an extraordinarily intricate and deliberate sophistication, indicating their potential function as components of cosmic energy flows.


This possibility was suggested in the text by Dr. Semir Osmanagić, "DISCOVERY OF THE TESLA'S TORSION FIELDS ABOVE THE BOSNIAN PYRAMIDS" [2], published in 2023. In this work, Osmanagić introduced the concept of a cosmic internet and the potential for near-instantaneous intergalactic communication within the universe, with pyramid-like structures serving as fundamental elements of this "cosmic hardware."

It is an indisputable fact that pyramid-like structures are characterized by specific geometry, unique structures, and highly unusual parameters that closely align with fundamental cosmic constants—despite being built thousands of years before Pythagoras, Leonardo Fibonacci, and John Napier (the natural logarithm)...



What is truly fascinating - and almost paradoxical - is that the exact same unique geometry characterizes Nikola Tesla's masterpiece, his "Magnifying Transmitter" in Colorado Springs. In the text "Nikola Tesla and the Pyramids" [3], published in February 2020, it was convincingly demonstrated that - even though Tesla never explicitly mentioned the pyramids, the golden ratio, Pi, the base of natural logarithms, or the Fibonacci sequence - all these values, which are embedded in every cell, shape, structure, and fabric of nature and the world, are also embedded in his machines!





This undeniable fact seems almost unbelievable. However, if we consider that Nikola Tesla was one of the greatest intuitive geniuses of this civilization—and that intuition serves as a "vehicle of the soul" for communication with Absolute Reality at the mental-causal level (3rd Loka...) [4], where all knowledge of past and future civilizations is stored in the form of the Morphogenetic Field or Akashic Records - then the possibility of accessing the deepest insights into the structure of reality from different space-time positions becomes conceivable for those who have reached the necessary level of consciousness.

From this perspective, it is entirely possible that, much like Maharishi Kapila¹, Tesla - through his intuitive genius, perseverance, and strenuous intellectual and physical work - managed to grasp the principles of Fractal, Quantum-Holographic Reality and design his Magnifying Transmitter as a harmonious part of the whole, fully synchronized with the macro, micro, and hyper aspects of reality. Thus, this device, in terms of its

sophistication, is entirely analogous to the Great Pyramid of Giza, a true masterpiece of knowledge and the deepest insights "stolen from Nature" (N. Tesla).

These facts serve as a powerful testament to the depth of Tesla's understanding of the Technologies of Perfection and Universal Cosmic Harmony, characterized by specific energy flow structures, achieved through very precise geometry - "the geometry of perfection" - and a unique design that aligns with fundamental cosmic constants (ϕ , π , e).

These facts are particularly reinforced by the latest discovery on the Giza Plateau, which points to the possibility that the entire complex, both its above-ground and underground parts, functioned as a unified system - a "great resonator", "amplifier", "modulator", "transformer" - of corresponding subtle-energy flows...

A strong argument indicating a full analogy between these considerations and the principles Nikola Tesla explicitly expressed in the construction of his "Wardenclyffe Tower" - the World Radio Station, which, besides transmitting speech, sound, and images, was also intended for "wireless energy transmission" - are the following well-documented Tesla statements [5], presented in their original form:

1. Nikola Tesla, Colorado Springs Notes, 1899-1900, June 5, 1899 (original):

"From this, the inferiority of the induction method would appear immense as compared with DISTURBED CHARGE OF GROUND AND AIR METHOD" !!!

Tesla wrote this note in his journal on June 5—just a few days after arriving in Colorado Springs, at the very beginning of constructing his apparatus—and even then, he was convinced of the advantages of a system not based on induction but rather on the unique properties of his machine and the specific nature of the entire system.

2. My Inventions – Chapter 6: The Magnifying Transmitter

"...it is accurately proportioned to fit the globe and its electrical constants and properties, by virtue of which design it becomes highly efficient and effective in the wireless transmission of energy. Distance is then absolutely eliminated, there being no diminution in the intensity of the transmitted impulses. It is even possible to make the actions increase with the distance from the plant according to an exact mathematical law."

This is one of Tesla's original statements that particularly emphasizes the importance of selecting the working **frequency**, **design**, **and geometry of each individual element** of his machine, and especially **their mutual and overall alignment with Planet Earth** and all its geometric, mechanical, and electrical parameters!

3. L.I. Anderson, Sun Publishing, Denver 1992, [pg. 203]:

"In this system that I have invented it is necessary for the machine to get a grip of the earth, otherwise it cannot shake the earth. It has to have a grip on the earth so that the whole of this globe can quiver, and to do that it is necessary to carry out a very expensive construction. I had in fact invented special machines... Now that was a very expensive part of the work, but it does not show on the tower, but it belongs to the tower."

From this Tesla statement, it is quite clear that **the importance of the underground part of the "Wardenclyffe Tower" is obviously equal to, if not greater than, its above-ground part,** because "the machine must FIRMLY GRIP THE EARTH... AND SHAKE IT WELL... SO THAT THE ENTIRE GLOBE CAN QUIVER !!!"

This Tesla instruction is absolutely impossible to explain from the perspective of the currently accepted version of electromagnetic theory, which may be the main reason for its complete neglect and dismissal. However, at the same time, it suggests full alignment of Tesla's principles with ancient knowledge and the principles of the Creator [6]. Accordingly, I believe we can safely say that Nikola Tesla was truly a follower of ancient knowledge, the ever-present principles of the Creator, and thus a visionary of the future.

Supporting this are the latest scientific considerations, which indicate a scientifically justified possibility of a correlation between the ether and quintessence - a hypothetical form of dark energy in the form of a scalar field, which could be the "fifth fundamental force," postulated by the latest cosmological model *Quintessence* as an explanation for the accelerated expansion rate of the universe. The word "quintessence" means "fifth essence," whose elementary quantum is the "fifth element" (*Quinta essentia*) - essentially, ether - bringing official science closer to ancient teachings.

Moreover, the latest experiments by the Hungarian Institute for Nuclear Research ([7], Attila Krasznahorkay and his colleagues) and the detection of the "X17" particle (a protophobic X boson, $m \sim 17$

MeV) during the energy release process of an excited helium atom suggest the possible existence of a new—"fifth force" in nature, alongside the electromagnetic, weak, strong, and gravitational forces. This particle could be a quantum carrier (like the photon is for electromagnetic interactions) and might be connected to dark matter and dark energy, and thus, through the *Quintessence* model, with the ether - giving Tesla's ether-based technologies full scientific legitimacy!

Considering the potential consequences of such ideas and experiments, the scientific establishment's reluctance is entirely understandable, as the existence of this particle would require a "restructuring" of the Standard Model of particle physics, as well as a reassessment of the limitations imposed by the Theory of Relativity.

However, it is worth remembering that the same group of Hungarian researchers who recently reported the discovery of the X17 particle also presented initial evidence of its detection back in 2016 in experiments with radioactive beryllium atoms - thus, by detecting the same particle in a completely different experimental setup, its "impossible existence" has become possible after all...

It is therefore quite clear that modern physics, with its latest insights and developments, is increasingly converging with Tesla's technologies and ancient teachings.

All this suggests the need - and, in fact, the necessity - for science to "take a few steps back" and reconsider some of its perhaps inadvertently but nonetheless hastily made decisions regarding the abandonment of the ether concept and the interpretation of scalar wave structures.

Returning to the concept of ether and reaffirming J.C. Maxwell's original theory - or at least "enhancing" the currently accepted "simplified" version by enriching "transversal-vector" electromagnetic theories with their natural longitudinal and vortex components (e.g., the work of Dr. I. Šimatović: *Hertzian and Non-Hertzian Waves* [8]) - is a possible and promising path to bringing all of Nikola Tesla's ideas and explanations of his technologies back into the scientific framework, thus making their realization much more feasible.

Consequently, all the unrealized ideas of this proven intuitive genius become attainable, and numerous so-called "pseudo-scientific" terms such as instantaneous intergalactic communication, teleportation, antigravity, zero inertia, zero-point energy, and similar concepts become much more acceptable.

The latest discoveries by the research team of F. Biondi, C. Malanga, and A. Mei, using Doppler tomography and synthetic aperture radar, may provide a basis for various speculations but also for very serious considerations about the knowledge of ancient civilizations, the depth of their insights into the structure of Absolute Reality, and the possibilities of their technologies, which might even become part of our reality.

Nikola Tesla - the follower of ancient knowledge—laid the foundation for future technologies with his ether-based technologies, making him a true visionary of the future.

In any case, studying ancient knowledge, pyramidal and sacred structures, as well as Tesla's legacy, can be of great help in understanding the Natural Mechanisms, the Creator's Matrix - the Supreme Creator - and in advancing humanity further.
